It was reported that the B5026 between Hilcote and Cold Norton has been left in a bad state of repair, a metal fence is missing along with a hedge</p> <p>The clerk has received an email regarding speeding traffic through Cold Norton and the state of the styles that lead from Eccleshall Road in Cold Norton to Yarnfield. The Clerk will report this to the Highways Department, P Lees, and the community Police Officer. Action Clerk</p>
1199	<p>Cold Norton Defibrillator. The replacement of the Defibrillator at Cold Norton was discussed, the Councillors agreed the replacement. The Clerk will arrange for the new Defibrillator to be ordered. Action Clerk</p>
1200	<p>HS2/ Network Rail</p> <p>HS2 update - Chebsey Parish Council Meeting - 4th Oct 2021.</p> <p><i>During the Summer months the HS2 project has rarely escaped the press. Whilst work continues apace on the phase 1 section to Birmingham, doubts have arisen about the viability, both publicly and in Parliament, as regards section 2b (eastern leg). The section 2a (Birmingham to Crewe), remains primarily a "desk design exercise" but ground testing has commenced along the route, including test drilling near the M6 overbridge at Cold Norton and also around the Fillybrook at Yarnfield Lane.</i></p> <p><i>The SRCG continues to lobby Parliament in opposition to the proposed IMRB from Yarnfield Land to the Stafford North Services. Although HS2 Ltd, remains fixed on the IMRB location, the case for its relocation to Aldersley Rough (AR) is continually being pushed by the SRCG. The SRCG technical team has recently supplied Parliamentary sources, including Sir William Cash and other vociferous anti HS2 MP's, with a fully costed design plan for AR. This will be presented to the HS2 Minister.</i></p> <p><i>Further reports will be made as new issues arise.</i></p> <p>Cllr. Robert Jones - 30th Sept 2021.</p>
